### WHAT HAVE WE RECENTLY ACHIEVED?

After the Second Transnational Partner Meeting in Portugal, CEX, FIP and INNEO worked hard to produce 6 enquiry-based and embedded-learning resources for drama, storytelling, and music in English for the First Intellectual Output of the project.

Also, ALK, RightChallenge and Hub Nicosia completed the development of the training programme and handbook for the In-Service Training Programme in order to teach adult educators to use alternative embedded and enquiry-based teaching resources.

ARTISTIC LICENCE is now entering an important phase when all the learning resources are going to be finalized and translated. For this reason partners made significant effort to ensure that everyone is familiar with their tasks and responsibilities.



### COMING NEXT...

Our work on the project will continue:

- After the finalizing English version of IO1, partners will translate and localize the content for all curriculum resources.
- IO2 – Programme and handbook to be completed and produced in a media format that will ensure maximum access for adult educators and migrant support workers.

## THE HOSTING PARTNER

The Third Transnational Project Meeting of the Artistic Licence Project was organized by the Polish partner – INNEO (The Center for Training and Research).

INNEO – is a non-profit association based in Rzeszów (Poland). The main mission of the organisation is providing training and research for social and economic development on local and European scale. The fields of expertise are labor market, entrepreneurship, education, and creative industries.

## THE MEETING'S SCHEDULE

The first day of the meeting started with the general introductions and greetings. Next, following the agreed schedule, partners made a short review of the project outputs, objectives and methodology. A large part of the meeting was dedicated to discussion on the resources developed by the ARTISTIC LICENCE partnership in previous months and reviewed the main aims and goals for months 13-18.

The second day of the meeting was spent on the dissemination of the products developed so far, and also discussed what action is needed to further improve the quality, effectiveness and impact of development co-operation.

Then partners set the implementation dates for the next transnational meeting in Prague, the duration and the exact content of the planned Cyprus Training Event.

The meeting was conducted in a friendly atmosphere, with clear divisions of upcoming tasks that lie ahead.
